General additional warranty conditions for all manufacturers.

The warranty period calculation starts from the invoice date. The warranty period is not extended in case of replacement or repair of services under this warranty. In such cases, the warranty period does not start over.

If defects in materials or manufacturing occur during this period, the manufacturer, as a guarantor, provides one of the following services at its discretion within the scope of the warranty - free repair of the product or free replacement of the product with an equivalent product (may be another model if the original product is no longer sold).

Warranty claims do not apply if the goods are damaged, faulty or defective due to:

- improper use according to the instructions for use,
- environmental influence, force majeure circumstances (humidity, heat, overvoltage, lightning, etc.),
- inappropriate, inconsistent or negligent conduct or use,
- non-compliance with safety measures,
- non-compliance with the instructions for use,
- faults caused by other connected devices,
- use of force (e.g. impact, fall, deformation, transport damage, etc.),
- unauthorized repair attempts.
- normal wear and tear.

A warranty claim assumes that the guarantor must be able to verify the warranty upon receipt of the shipped goods. Shipping costs are paid by the customer. It is important to ensure that damage is prevented during transport by using suitable packaging.

To apply for a warranty, you must attach a copy of the original invoice and a description of the suspected defect according to the manufacturer's service form, which will be provided when applying for the warranty. The defect must be confirmed no later than 14 days after its occurrence. Please understand that the manufacturer may void the warranty without attaching a copy of the invoice. A copy of the invoice is used to calculate the warranty period. The seller's details and address must also be provided if this is not obvious from the attached copy of the invoice.

All components replaced under warranty become the property of the manufacturer.

If the warranty claim is justified, the warranty service is free for you. ***Returning the product to the specified address is charged according to the current transport costs.***

NOTE:

UAB "Auviras" is only an intermediary in providing an additional manufacturer's warranty and does not assume any responsibility for the decisions of the manufacturers who provided this additional warranty, unfulfilled or improperly fulfilled obligations, and changed warranty conditions, should such cases occur.

In order to file a claim with the manufacturer, the product must be delivered to UAB "Auviras" first. Transportation costs to both sides are paid by the customer.
